### **Letter from the President**

Dear Arts Council friends and members.

As I look forward to the promise of a new year, it is worth pausing to reflect on my first year as President. Among the Arts Council's many outstanding accomplishments, two stand out to me.

Last spring, I was part of a group of community leaders that embarked on a listening tour to discuss common goals and identify areas that need to be strengthened to advance the arts and build a more connected, creative community. We met with the directors and board presidents of ten organizations involved in the production and promotion of the arts. Communications and marketing along with collaborations and partnerships (including shared back office services

and infrastructure) were the top areas cited by participants. These discussions resulted in a new cooperative online marketing opportunity launched by Howard County Tourism and a new capacity-building grant opportunity to develop partnerships through the Arts Council.

Last spring, the Arts Council also began its strategic planning process. Led by consultants Schultz & Williams, the intensive, in-depth process was informed by insights gleaned from the listening tour; one-on-one interviews with staff, current and former Board members, and key external stakeholders; a Board survey; a review of past program, financial, and historical materials; a Board bus trip to two local arts councils; and a full-day Board retreat. In June 2018, the Board approved our five-year strategic plan and set goals focusing on:

- Community Arts Development
- Community Engagement
- Financial Sustainability
- Programs and Services
- Organizational Capacity

As Board President, I found both of these activities extremely valuable. Having served on the Board for the past five years, I believed I had a good understanding of the county's arts community. However, with each discussion and each moment spent listening, I gained deeper insights into the challenges and opportunities for both the Arts Council and the wider arts community.

What is clear to me is how passionate our community arts leaders are about producing challenging, meaningful, and high-quality programs; how hard they work to engage audiences; and how vital and diverse the organizations they operate, and the programs they produce, are. Also clear is how much the arts community values the Arts Council's advocacy, leadership, and support.

As Howard County continues to grow and thrive, there is no doubt that the arts must continue to be an important part of community planning and growth, public education,

**Grant & Scholarship Recipients •** The Arts Council awards more than \$500,000 annually through a variety of grant programs. It's one of the key ways that we foster a vital arts community. **HoCo Open 2019** is a non-juried exhibit open to artists (aged 18 years and older) who live, work, or study in Howard County. Eligible artists are invited to bring one piece of ready-to-hang original artwork completed in the past two years to the drop-off on January 3 (snow date: January 4) from 4:30-6:30pm. Artwork will be accepted for the exhibit on a first-come basis, one piece per artist, until the gallery is full. A highlight of *HoCo Open 2019* will be the presentation of the \$500 Covington Emerging Artist Award, established by local gallery owner Robin Holliday to recognize and support an emerging artist at a pivotal time in their career. **ARTsites 2019.** The Arts Council is seeking proposals from artists and sites for ARTsites 2019, a one-year outdoor sculpture exhibit on display from August 2019 to July 2020. Selected artists will be awarded a grant to participate in the exhibit. Deadline to apply is March 1, 2019. Submission guidelines will be available December 1 at hocoarts.org.

Arts Scholarship. Is a visual arts, theatre, music, dance, or creative writing degree in your future? If so, you'll definitely want to apply for our Arts Scholarship program. Online applications are available at hcac.gosmart.org. Deadline to apply is January 16, 2019.

**MannegART.** Wearable art entries are sought for the 7th Annual MannegART Sculptural Artworks Competition. Themes for 2019 are Insects, Amphibians, Objects, and Aliens. \$10,000 in artist awards will be given to the best of each theme, to student winners, and to an overall Master Award winner. Entry applications are available January 1 at mannegart.org. Early Bird application deadline is March 31; final deadline for entries is May 15, 2019.

**Baker Artist Awards** recognizes artists from the Baltimore metro region who exemplify a mastery of craft, depth of artistic exploration, and a unique vision. Artists who create a Baker Artist Portfolio are automatically eligible for one of five Baker Artist Awards, which include significant monetary prizes, an exhibition at the Baltimore Museum of Art, as well as a feature on Maryland Public Television's *Artworks* program. Artists have until 5pm on December 21, 2018 to create or update their portfolio. Visit **bakerartist.org** for details and to create a portfolio.

**HCAC exhibit applications** are due January 1, 2019. Exhibits are selected and presented in the context of multidisciplinary, thematic, juried, and invitational exhibits. Curators and artists are encouraged to apply. Applications are available at hocoarts.org.
