Dear Arts Council members and friends,

In fiscal year 2021-22, the Arts Council, along with other public-facing organizations, tried to get back to normal. Are we there yet? Not quite. We're still facing the lingering effects and uncertainty of a global pandemic, but we've certainly come a long way.

In July 2021, after 16 months of operating primarily in a digital space, the Arts Council opened our doors full-time, cautiously welcoming visitors and audiences back to the Howard County Center for the Arts. We drew on our reserves of patience and resilience – along with the support of our friends and members – to navigate new COVID variants and provide safe opportunities for artists and arts groups to create and present their work, while drawing 24,000 visitors (68% of our pre-COVID attendance). We are excited about our progress so far and optimistic about the future!

Howard County's partnership with the Arts Council has been essential to our recovery, and to the recovery of the entire arts community. We'd like to thank County Executive Dr. Calvin Ball and Council members Opel Jones, Deb Jung, Christiana Mercer Rigby, Liz Walsh, and David Yungmann for their stalwart support of the Arts Council and for providing us with \$905,500 in direct funding as well as additional support to produce a family-friendly arts festival for the Long Reach community. Their investment in the arts is critical to ensuring public access to the arts and supporting diverse art forms in our community.

We received a record \$193,238 from the Maryland State Arts Council – a 13% increase – and a commitment for additional recovery funds in the coming year, thanks to the leadership of Governor Hogan and our state delegation in Annapolis.

In other good financial news, our earned income grew, our memberships and sponsorships remained healthy, and we received our first six-figure planned giving commitment. Our financial position at year-end was strong.

Creating an environment where artists can thrive and the public can engage in the arts is an important goal for the Arts Council. In FY22, we awarded 60 operating and project grants totaling \$616,000 in public funds to arts organizations and PTAs. And, we provided \$190,000 in both private and public funds to individual artists in the form of scholarships, grants, fees, and honorariums.

In addition to awarding grants, we:

- mounted 14 original exhibits featuring the work of 289 artists and 350 student artists.
- hosted our first juried Holiday Arts Market in conjunction with our annual Holiday Maker-Mart.
- placed 12 new temporary outdoor sculptures at 12 community sites through our ARTsites program.

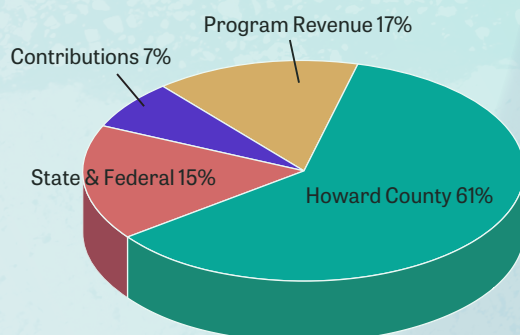

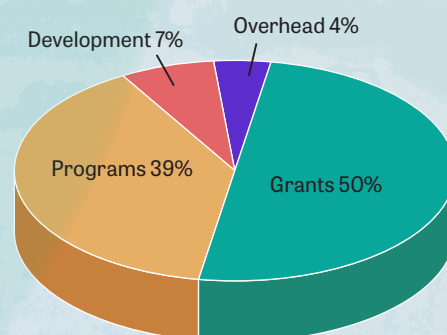

- provided affordable studio space to 14 visual artists and 3 arts groups at the Center for the Arts and 15 visual artists at our studios in Long Reach.
- piloted a new Creative Aging program for seniors.
- produced ARTreach, a free, family-friendly arts festival at Long Reach Village Center. Over 2,000 community members attended, enjoying the sounds of six world music bands and artmaking activities and demonstrations ranging from tie-dye to piñata-making to caricatures to silhouette-cutting and much more. Nearly 80 volunteers participated and 117 visual and performing artists were featured.
- modified our summer camp program and welcomed 877 campers back.
- provided affordable rehearsal, workshop, meeting, and performance space to over 60 artists and arts groups.
- partnered with Visit Howard County to host the popular four-day Paint It! Ellicott City paint-out in historic Ellicott City with over 85 juried and community artists setting up their easels and capturing the charming sites of the old mill town.
- created a video to promote our Long Reach Studio artists.
- placed visiting artist Marcie Wolf-Hubbard in a year-long artist-in-education residency with 57 pre-K students at the Ellicott City Head Start Center. The artist and students each created their own tiny houses, which were displayed at the Center for the Arts and featured in a sharing assembly during the Head Start graduation ceremony. The residency was supported by The Isadore and Bertha Gudelsky Family Foundation.
- returned to the Jim Rouse Theatre to hold our hybrid in-person and virtual Celebration of the Arts gala, which marked our 40th anniversary. The gala featured our popular Rising Star Performing Arts Competition and a special Collector's Preview for our benefit exhibit and art auction.
- continued our monthly Arts Chats to help connect local arts groups and supported local artists and arts groups through a new monthly artist opportunities e-newsletter and a new monthly feature highlighting our grantees.
- expanded our social media presence with increased activities reaching 58,205 unique visitors through our website, monthly e-newsletter, Facebook, Twitter, and Instagram.
- recognized six individuals for their significant impact on the arts in our community:
 - ~ Poet Linda Joy Burke received the Howie Award for Outstanding Artist;
 - ~ Patricia Hunter, Homewood Art Teacher, and Eric Posner, Atholton High School Director of Bands, received Howie Awards for Outstanding Arts Educator;
 - ~ Phyllis Madachy received the Howie Award for Outstanding Community Supporter of the Arts (posthumously)
 - ~ Linda and Philip Press received the Legacy in the Arts Award.

Grant Programs

Howard County Arts Council grants are awarded based on artistic merit, ability of the applicant to carry out the project and level of service to the community. Grantees are selected through a competitive process in which applications are reviewed by a volunteer advisory panel made up of academics and artists representing a variety of disciplines. Grant award recommendations are then reviewed and approved by the HCAC Board of Directors. In FY22, HCAC awarded \$616,353 in matching grants to 49 organizations.
