The Howard County Arts Council (HoCo Arts) is a nonprofit organization whose mission is to enrich and uplift our communities by advancing the arts, artists, and arts organizations for the benefit of all. To fulfill its mission, HoCo Arts offers a wide variety of programs and opportunities - grants to local and regional arts and cultural groups; exhibits; affordable studio, performance and meeting space for artists; classes for children and adults; a quarterly newsletter; arts advocacy and awareness initiatives; and others that are essential to artistic development in Howard County. In December 2025, HoCo Arts will move into the newly renovated Historic District Courthouse in Old Ellicott City along with two other organizations. The HoCo Arts managed spaces will be used as a multi-disciplinary art center providing opportunities in the arts for people of all ages, backgrounds and abilities. The HoCo Arts spaces will feature two professional galleries, a 120-seat black box performance space, meeting and class rooms, a dance studio, individual artists' studios, office space for nonprofit arts groups, and HoCo Arts administrative offices.

HOWARD COUNTY ARTS COUNCIL RESIDENT STUDIO ARTIST APPLICATION GUIDELINES

The deadline to apply is 11:59 PM, Monday, September 15, 2025.

The Howard County Arts Council is seeking applications from artists to fill up to ten resident artist studio spaces at our new location at the Historic Courthouse in Old Ellicott City. The size of available studios range from approximately 90-350 square feet and rent for \$72.38 - \$281.46 per month for Howard County residents or \$87.75 -\$341.25 per month for out of County residents.

Applicants will be considered by the HoCo Arts Center Committee.

Our new space at the Historic Courthouse will house accessible studio space for eighteen resident studio artists, as well as three resident arts organizations representing a variety of disciplines. Resident artists will have 24-hour access, natural light, and easy access to water. Utilities and public wi-fi are included.

Residency Objectives

To provide individual artists with a space in which they may pursue the production, presentation, or teaching of fine arts. The fine arts include traditional and emerging art forms within, but not limited to, visual, performing, and literary arts.

To support a diverse community of artists working in a variety of fine arts media and disciplines.

To provide the public with opportunities to meet working artists.

Benefits

General benefits include: private studio, 24-hour access to designated studio, physical mailing address and mailbox, affordable monthly rental rate, and location in a vibrant community arts center in the heart of Old Ellicott City.

Residents also receive a reduced rate and priority consideration for renting other spaces in the HoCo Arts Center including the dance studio, black box theatre, multi-purpose room, and classrooms.

Eligibility

Practicing artists who demonstrate a central commitment to the production or performance of fine arts. In some studios, practicing artists may also teach in their studio space.

HoCo Arts Board of Directors and full-time administrative staff, HoCo Arts Center Committee, and their immediate family are ineligible to apply.

- Letter of Intent
 - In one page or less, provide a brief description of your work or project to be completed while in residence, your career direction, and why you should be awarded a residency.
- Up-to-date Resume
 Three pages or less that lists education, background, exhibitions, awards, and/or publications.
- Artist Statement
 In one page or less, concisely describe your creative work, process, technique, and conceptual development.
- Three Letters of Recommendation

Include references which speak to your character, responsibility, and contribution to community and provide at least one financial reference who can speak to your ability to pay bills on time.

- Up to 20 Images Created within the Last Two Years that represent your work:
 - Include at least one video recording if applying for performance art or video work, link to YouTube or Vimeo preferred.
 - Videos must not exceed five minutes in duration, if the video is longer, please provide a cue to start. If a cue is not provided, only the first 5 minutes will be reviewed.
- Image List

Typed list of images which include title of artwork, media, size, and date created. If available, include digital examples of printed materials such as articles, brochures, programs, and reviews submitted in pdf form, not to exceed 10 pages.

Requirements

Applicants granted studio space will be considered HoCo Arts Resident Studio Artists.

To hold a HoCo Arts Resident Artist studio space, artists must, at a minimum, fulfill the following:

- Resident Studio Artists are required to participate in the Residents' Exhibit, displaying recent work (created within two years prior to the exhibit), not previously shown in the gallery, for a six-week show.
- Resident Studio Artists are required to be in attendance for up to five HoCo Arts scheduled Open Studio special events per year when they must be present and open their studios for public viewing.
- Resident Studio Artists must use their studios for a minimum of eight hours per week (annual average). Those eight hours must be used for the production, presentation or teaching of their art and not for other unrelated employment or activities.

Resident Studio Artists must pay the studio rent within five working days of the first of each month.

- Resident Studio Artists must maintain a \$1,000,000 general liability insurance policy for their studio as well as coverage for the contents of their studio.
- Resident Studio Artists must maintain a safe working environment in their studios and submit and keep current appropriate MSDS forms for hazardous materials in their studios. Furthermore, they are expected to practice a "good neighbor" policy, using the least harmful materials possible and keeping in mind not only their own health and safety, but also that of the Center community.
- Resident Studio Artists offering classes, exhibits, or other public programs must be fully accessible.

- Residents Studio Artists must maintain annual membership with HoCo Arts.
- Any physical changes to the studio, which includes painting, must be approved by the HoCo Arts Center Committee and the County, residents must return the studio to its original condition when vacating.

Selection

The HoCo Arts Center Committee will review and evaluate applications based on their artistic discipline, artistic merit and commitment, as well as the appropriateness of their activities for the available space. A key objective of the program is to have a variety of styles, viewpoints and media represented in the studio program and the Committee will consider the current make-up of Resident Studio Artists during the review process. In cases where all other elements of applicants' qualifications are deemed of equal value, Howard County residents will be given priority.

The HoCo Arts Center Committee will review and rank eligible submissions in October and select finalists to tour the new building in October/November. The finalists will provide their top three studio choices, and the Committee will finalize the selection process and assign studios.

Access

The following are policies regarding building access:

- The building is owned and operated by the Howard County Government. Each Resident Artist must undergo a non-employee background check with the County before receiving a key badge, which will give them access to select exterior doors and their studio.
- 24-hour access is allowed for the Resident Artist only; guests, students and members of
 the public are not permitted outside of building hours unless a request to keep the
 building open after public hours has been made and approved by HoCo Arts to secure a
 building attendant. If approved, any costs to keep the building open will be paid by the
 Resident Artist.
- No pets are allowed on the premises.

Residency Term

Resident Artist status will be granted for a probationary one-year term. At the end of the term, the Resident Artist will be evaluated and may reapply to extend their residency through two-year renewable terms or until the termination of the Arts Council's Master Lease, whichever expires first.

Resident Artists are reviewed for compliance with the terms of their lease before each lease renewal. Those residents who have met the requirements will have their lease renewed for two years. Residents who do not meet the required terms will be placed on probation and given a minimum three-month to a maximum of one-year conditional lease. If requirements are met, conditional leases will be extended with Center Committee approval. If the conditional leaseholders are not approved, they will be given one month to vacate the premises.

Additional Information

This request is intended to give a broad outline of the residency. Final details will be negotiated after an artist is selected.

HoCo Arts Center Committee selection decisions are final. HoCo Arts reserves the right to modify or extend the Resident Studio Artist Request for Applications for any reason at its sole discretion.

Application

Only eligible and complete applications will be forwarded to the HoCo Arts Center Committee for consideration.

All application materials must be submitted online through the application portal by 11:59PM, September 15, 2025. <u>Mailed, emailed, faxed or late applications will not be accepted.</u> Email by Monday, September 8, 2025, for application assistance and accommodations.
